CNSC to conduct a public hearing on Ontario Power Generation’s application to renew its Darlington Waste Management Facility operating licence

The Canadian Nuclear Safety Commission (CNSC) will hold a public hearing on January 25 or 26, 2023, to consider an application from Ontario Power Generation (OPG) to renew its waste facility operating licence for the Darlington Waste Management Facility for a period of 10 years. The Darlington Waste Management Facility is located on the site of the Darlington Nuclear Generating Station in the Municipality of Clarington, Ontario, on the traditional territory of the Wendat, Anishinabek Nation, and the territory covered by the Williams Treaties with the Michi Saagiig and Chippewa Nations. **This revised notice is to announce a change to the location of the public hearing. The hearing will now be held virtually only.**

The current licence, which expires on April 30, 2023, authorizes OPG to operate the Darlington Waste Management Facility to process and store dry storage containers holding used nuclear fuel from the Darlington Nuclear Generating Station.

The public hearing will be webcast live and available on the CNSC website at nuclearsafety.gc.ca.

To assist Indigenous Nations and communities, members of the public and stakeholders in reviewing OPG’s application and associated documents, and as previously set out in the [notice of public hearing](#) published on July 21, 2022, participant funding of up to \$75,000 was made available through the CNSC’s [Participant Funding Program](#) (PFP). The deadline to submit a completed participant funding application form to the CNSC was August 19, 2022. Information on the PFP decision will be posted on the CNSC’s website in early November 2022.

OPG’s submission and CNSC staff’s recommendations to be considered at the hearing, as well as [OPG’s application](#), are available on the [CNSC website](#) or on request to the Commission Registry.

Pursuant to rule 19 of the [Canadian Nuclear Safety Commission Rules of Procedure](#), persons who have an interest or expertise in this matter or information that may be useful to the Commission in coming to a decision are invited to comment on OPG’s application. Requests to intervene must be filed with the Commission Registry by **December 5, 2022**, using the [online](#)

[request form](#), [by email](#), or the contact information below. **The request to intervene must include the following information:**

- a written submission of the comments to be presented to the Commission
- a statement setting out whether the requester wishes to intervene by way of written submission only or by way of written submission and oral presentation
- the requester's name, address, telephone number and email address
